***PLEASE NOTE: THE REVERSION OF AN EASEMENT MAY RESULT IN AN INCREASE OF PROPERTY VALUE FOR TAX PURPOSES.

If the easement you wish to revert crosses property you do not own, one of the following will be required:

- The abutting owner(s) will need to complete and sign a new application to be submitted with the Applicant's request -OR-
- A notarized letter from the abutting owner(s) stating they agree with the easement reversion must be provided with the Applicant's request -OR-
- A survey must be obtained, from a registered licensed surveyor, indicting the portion of the easement on the Applicant's property to be reverted
